MESSAGE FROM THE BOARD CHAIR



It is a distinct honour to Chair the volunteer Board of Directors of the Hospitals of Regina Foundation and to oversee its governance. I speak on behalf of my Board colleagues when I say that we are very proud of the successes in the past year – a year of significant transition.

In the early summer of 2014, long-time CEO of the Foundation – Judy Davis – retired after a very successful career building upon the earlier good work of her predecessors. She left the organization financially strong and in a state of readiness to reach "the next level." The Board is very grateful for her dedication and commitment to the organization. After a short-time as her successor, Pat Fiacco left the organization to pursue other business interests. A transition from two CEOs in one year might prove tremendously challenging for some, but in this case, it has produced a staff who are more team-oriented than in the past and who have risen to the challenge of working at times independently and at other times as a motivated self-directed team. The Board sees this as very positive and is certain that this evolution has created a strengthened, vibrant and more strategic organization.

I must thank our generous donors and event sponsors. As the champions of our accomplishments, individuals and corporations alike have provided financial support for the innovative, state-of-the-art technology and equipment that lead to better patient care experiences. This support makes a difference in peoples' lives. The impact of the HRF would be nothing without each person and each organization that chooses to direct discretionary charitable dollars to purchase capital equipment and technology for our hospitals. Our appreciation for your contributions cannot be overstated, and we thank you and applaud the support we receive from our community.

Equipped with a new five-year Strategic Plan that will propel the organization forward, the Board and HRF staff are excited and enthusiastic about the possibilities and opportunities that lie ahead to make a continued difference in the lives of the people of southern Saskatchewan. Developed with the involvement of our partners at RQHR, the plan sets a path for the organization's future activities.

I am pleased to provide the following highlights, as just a few of our 2014 accomplishments:

 The Spring and Fall Home Lotteries raised over \$3 million – \$1.4 million in the fall and \$1.75 million in the spring – both once again selling out prior to the Early Bird draw. Since the inception of the lottery program in 1987, an impressive total of \$29 million has been raised to buy medical equipment and enhance education and research.

- Accomplishing its three-year goal, the Eberle & Friends Golf Classic sponsored by the Cooperators, Mosaic, Conexus and several other organizations has raised an incredible \$1 million since its inception.
 With a reputation as one of the premier golf events in Regina, this event raised an unprecedented \$500,000 in 2014 to build the High Acuity Area at the Regina General Hospital to amalgamate pediatric services.
- The Million Dollar Match Surgical Campaign sponsored by PotashCorp surpassed its goal of raising \$2 million, for a total of \$2.5 million that will go towards specialized surgical equipment. This equipment will have a tremendous impact on surgeries, early detection of illness and disease, and quicker patient recovery time.

 In its 27th year, Rawlco Radio's Z99 Radiothon continued to support the Neonatal Intensive Care Unit by raising \$728,000 from our community to save and protect the lives of babies.

From improving cardiac and emergency room care and services to supporting pediatrics and neonatal units, to providing leading-edge preventative and detection equipment for breast and prostate assessment services, the Hospitals of Regina Foundation is proud of its continuing commitment to support healthcare in southern Saskatchewan.

We look forward to your continued partnership and support in 2015 and beyond.

OUR ACCOUNTABILITY



As a non-profit charitable organization, the Hospitals of Regina Foundation's focus is on achieving excellence in fundraising through the principles of transparency, accountability and efficiency. We would not be successful without these principles.

We focus on meeting the standards and following the guidelines of Imagine Canada, the Association for Healthcare Philanthropy, and the Canada Revenue Agency.

• Imagine Canada

The HRF adheres to Imagine Canada's Ethical Code Program. The primary purpose of the Ethical Code is to assure donors of the integrity and accountability of charities that solicit and receive their financial support. Charities that adopt this Ethical Code commit to fundraising practices that respect the donors right to truthful information and privacy. They also commit to responsibly manage the funds that donors entrust to them, and to report their financial affairs accurately and completely. Participants are required to annually submit their audited financial statements and a short report confirming that the charity is in compliance with the Ethical Code.

• Association for Healthcare Philanthropy (AHP)

As an international professional non-profit organization, AHP is the leading international education organization and advocacy body for healthcare fundraising professionals in Canada. Established in 1967, AHP's 4,700 members represent more than 2,200 healthcare facilities in Canada and the U.S.

• Canada Revenue Agency (CRA)

The HRF adheres to Canada Revenue Agency's fundraising guidelines, including the requirement by CRA to file a T3010 Information Return which provides information to the CRA and to the public about a charity's activity (including financial information).

BUILDING A HEALTHIER COMMUNITY



Management is responsible for preparing the accompanying summarized financial statements and is responsible for their integrity and objectivity. The Foundation maintains systems of internal accounting and administrative controls of high quality, consistent with reasonable cost. Such systems are designed to provide reasonable assurance that the financial information is relevant, reliable, accurate and complete in all material respects, and that the Foundation's assets are appropriately accounted for and adequately safeguarded.

The Board of Directors is accountable for ensuring that management fulfills its responsibilities for financial reporting, and is ultimately responsible for reviewing and approving the financial statements. The Board carries out this responsibility principally through its Audit and Finance Committee, whose members are appointed by the Board. The Audit and Finance Committee meets with management and the external auditors to discuss internal controls over the financial reporting process, audit findings, financial reporting issues, and to gain assurance that each party has properly discharged their responsibility. The Audit and Finance Committee reports its findings to the Board for consideration when approving the financial statements for issuance to the members in the Annual Report.

Due to the summarization of financial information, the basis of presentation included in this report does not include all disclosures that conform to Canadian accounting standards for not-for-profit organizations. The complete financial statements include all disclosures and are prepared in accordance with Canadian accounting standards for not-for-profit organizations.

REGINA GENERAL HOSPITAL

The Regina General Hospital is a major referral centre for southern Saskatchewan and offers numerous specialties including cardiosciences, neurosciences and critical care. It is home to the Mosaic Heart Centre – recognized as a leading cardiac facility in Canada, and the Rawlco Centre for Mother Baby Care – one of the best mother-baby facilities in Canada.

PASQUA HOSPITAL

The Pasqua Hospital is at the forefront of many programs including ophthalmology, orthopedics and cancer services.
